

## MINUTES

Whitefish Fire Service Area  
Trustees Meeting 3/15/22  
Fire Station #22

Call to order: 6:30pm

- Present: Mark Carlson, Dennis Oliver, George Losleben, Ed McGrew, Molly Miller
- Guests: Joe Perry, Becky Briber, Scott Miller, Tristan Thomas

Approval of 2/15/22 minutes, with the following amendment:

- *Mark Carlson announced that Jimmy Deats had resigned his seat, effective immediately. New trustee Molly Miller will fill out Deats' term on the Board through May and begin a new term in June 2022.*

New Secretary:

- Molly Miller voted and approved to take over Secretary duties from Ed McGrew

Public comment:

- Tristan Thomas, owner of Star Meadows Ranch, had attended The Homestead fire meeting and was opposed to the proposal presented to create a new rural fire district with a fire station at Star Meadows Rd and Farm-to-Market Rd
  - Discussed possible recourse with county commissioners
  - Not within WFSA control
- Scott Miller, former recruiter for career and volunteer firefighters, had read the agenda in the newsletter feed
  - Regarding the Fire Station 22 dormitory, recommended trailers or pre-fab housing big enough for a family as a recruitment draw
  - Regarding rate increases, suggested trustees develop a 5- or 10-year plan to explain increases; favors forming a district

## Current business:

- Bills paid:
  - 2938 USPS \$182.00 (P.O. Box)
  - 2939 NWE \$394.52
  - 2940 FEC \$106.00
  - 2941 Big Drift \$500.00
  
- 2022 budget process
  - Is there a way to put financials online for greater transparency; can bill paying happen offline?
    - County controls budget/bank account; WFSA has an allocated fund
  - Balance of working fund sufficient to cover remaining tower repair costs
    - Working Fund Balance: \$231,053.82
    - Capital Improvement Fund Balance: \$856,477.20
  
- Steering committee report
  - Purpose originally to compare fire service costs across other fire service areas and districts
    - Ed McGrew investigated and no further action required
  - New charter to prioritize AP Triton Study recommendations regarding WFSA and develop appropriate implementation strategies
  - Work is still in process after initial meeting; priorities to come
  
- Carnegie Mellon study follow-up
  - Discussed whether we need follow-on data regarding optimal Number of Lives Saved per station location or whether that data was analyzed in original study
  
- The Homestead long-term plan
  - Covered above under *Public Comment: Tristan Thomas*

- Fire Station 22 dormitory
  - Hire architect to design addition to fire hall?

- Coordinate with City regarding Master Plan, personnel, equipment and funding

- County Wildfire Protection Plan (CWPP) as part of education/PR effort?
